Welcome to Tbilisi

Editorial and welcome

Since my reporting about the project “How Georgians view democracy?” in Sophia 2004 many waters flowed under the bridge. The more important that I can welcome you again in Tbilisi.

In fact Georgia has achieved several macro objectives, which include getting closer to NATO, tripling the state budget (for the last three years the Georgian budget has had a surplus), combating corruption, carrying out reforms in several fields, education, health care, law enforcement and attracting foreign investors. However, many things still remain problematic and there is much work that needs to be done to sort them out.

Where does Georgia stand today? What should we do in the Caucasus region, mainly with the project YOUTHLAB (*Youth, labour markets and integration into local societies in Central Asian and Caucasian countries*) as a new initiative?

At this moment Georgia is at the stage to make the real breakthrough and move even faster in terms of reforms and integration to the West. Georgian reforms set a good precedent for neighbouring countries, such as Azerbaijan and Armenia. As an example – right after introducing new traffic police in Georgia a practically not corrupted institution, Azerbaijan “copied” and followed. It is now trying to implement the same model. However, coping institutions without sharing experiences will likely not be successful.



And in this light, I believe that YOUTHLAB could play a driving force. This is especially true if scholars in three Caucasian countries, together with our Western and Eastern European partners would be involved. One of the main objectives shared for the future is that all three countries have inspirations towards entering the European Union. Naturally, this is a long process, and it is always better to start later than never.

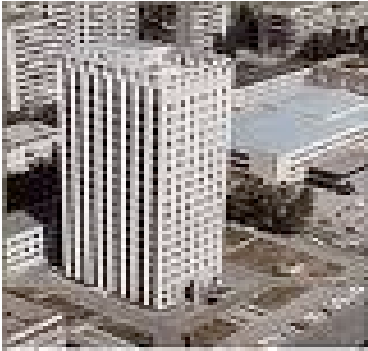
All three countries, apart from the common history, have much in common: conflict zones and unsolved disputes concerning those territories, economy problems and unemployment, and more importantly, informational gaps that should be bridged by scientific approaches and comparative analyzes on what are the public demands and how could the future of our mutual relationships be figured out. The problems and tasks are urgent and very clear.
